 - "Your honors are so high up there, we are so low down here."



- It would be great if laypersons have something that could gauge the justice qualities over time, especially after there is a claim that has just been criminal justice reform.





 - ✓ Capacity





This is how does the TIJ perceive criminal justice indicators in a professional term.





With the measurement tool, we hope the underprivileged people would be no longer too small.




